Diverse program offerings for people of all ages include exciting science theater shows and facilitations, lectures, documentary film screenings, school break camps, and family activity programs. ExciteEd programs for schools include rigorous teacher professional development classes and school group Field Trips. In 2022, the Museum

(Revenue \$) Science Division: Museum researchers contribute to scientific knowledge through collection and analysis of data, which are then used to generate and publish new understandings about the earth, its inhabitants, and beyond. The Science staff manages, preserves, and provides access to the Museum's collection of 4.3 million objects and specimens. During 2022, staff fielded 587 research requests from collaborators inside and outside the museum. The Science Division also engaged in abundant educational outreach, communicating science to 126,234 members of the general public and its research community through courses, events, tours, lectures, and fieldtrips in 2022 alone. 4,445 of these guests attended collection open houses or behind the scenes tours of the Avenir Collections Center, and 44,404 of these
